

KOREA VISA REQUIREMENTS

REQUIREMENTS FOR TOURIST AND VISITOR'S VISA¹

FOR EMPLOYEES

1. Application form; 1 piece of passport size colored picture
2. Original passport (valid more than 6 months); Photocopy of Bio-page (page 2)
3. Original & photocopy of valid visa(s) and arrival stamps to OECD member countries for the 5 years (if applicable, and Korean Visas will not be counted)
4. Original Certificate of Employment (with contact number/s and address of company and date of issue)
5. Original Personal Bank Certification (NOT Bank Statement)
6. Photocopy of ITR (Income Tax Return) or Form 2316

FOR BUSINESSMEN

1. Application form; 1 piece of Passport size colored picture
2. Original passport (valid more than 6 months); Photocopy of passport Bio-page (page 2)
3. Original & photocopy of valid visa(s) and arrival stamps to OECD member countries for the 5 years (if applicable, and Korean Visas will not be counted)
4. Photocopy of Business Registration from SEC or DTI
5. Photocopy of Business Permit or Mayor's permit
6. Original Personal Bank Certificate (NOT Bank Statement)
7. Photocopy of ITR (Income Tax Return) or Form 2316

FOR FOREIGN NATIONAL RESIDING IN THE PHILIPPINES

1. Application Form; 1 piece of Passport size colored picture
2. Original passport (valid more than 6 months); Photocopy of Passport Bio-page (page 2)
3. Original and photocopy of valid visa/s and arrival stamps to OECD member countries for the past 5 years (if applicable, and Korean Visas will not be counted)
4. Photocopy of ACR I-Card and Philippine Visa
5. Original Personal Bank Certificate
6. If student: Original School Certificate and Photocopy of School ID
If Employee: Original Certificate of Employment and ITR or Form 2316
If Businessman: Photocopy of SEC or DTI, Mayor's Permit and ITR or Form 2316

FOR FILIPINO STUDENTS

1. Application Form; 1 piece of Passport size colored picture
2. Original passport (valid more than 6 months); Photocopy of Passport Bio-page (page 2)
3. Original and photocopy of valid visa/s and arrival stamps to OECD member countries for the past 5 years (if applicable, and Korean Visas will not be counted)
4. Original School Certificate and photocopy of Student I.D.
5. Photocopy of NSO Birth Certificate of an applicant
6. Parents' Financial Support Document
 - a. Original Certificate of Employment (or DTI or SEC or Mayor's Permit)
 - b. Original Bank Certificate (NOT Bank Statement)
 - c. Photocopy of ITR or Form 2316
7. Affidavit of Support Notarized from parents

FOR KOREAN'S BROTHER/SISTER-IN-LAW

1. Application Form; 1 piece of Passport size colored picture
2. Original passport (valid more than 6 months); Photocopy of Passport Bio-page (page 2)
3. Original and photocopy of valid visa/s and arrival stamps to OECD member for the past 5 years (if applicable, and Korean Visas will not be counted)
4. NSO Birth Certificate of applicant
5. Certificate of Marriage History (w/in 3 months)
6. Copy of Korean Passport (first page)
7. Copy of Married Filipino's Passport (first page)
8. Married Filipino's NSO Marriage Certificate
9. Invitation Letter from the Korean National
10. If the applicant is employed: Original Employment Certificate, Original Personal Bank Certificate and Copy of Income Tax Return (ITR)
11. Processing time: 5 working days (not including the day of filing)

FOR KOREAN'S PARENT'S IN LAW

1. Application Form; 1 piece of Passport size colored picture
2. Original passport (valid more than 6 months); Photocopy of Passport Bio-page (page 2)
3. Original and photocopy of valid visa/s and arrival stamps to OECD member countries for the past 5 years (if applicable, and Korean Visas will not be counted)
4. Certificate of Marriage (w/in 3 months)
5. Copy of Korean Passport (first page)
6. Copy of Filipino's Passport (first page)
7. Married Filipino's NSO Marriage Certificate
8. Invitation Letter from the Korean National
9. Processing time: 3 working days (not including the day of filing)

FOR FILIPINO MARRIED TO KOREAN (Tourist Visa)

1. Application Form; 1 piece of Passport size colored picture
2. Original passport (valid more than 6 months); Photocopy of Passport Bio-page (page 2)
3. Original and photocopy of valid visa/s and arrival stamps to OECD member countries for the past 5 years (if applicable, and Korean Visas will not be count)
4. NSO Marriage Certificate
5. Certificate of KOREAN Marriage History (w/in 3 months)
6. Copy of Korean Passport (first page)
7. Invitation Letter for Spouse
8. If Korean lives together with spouse in the Philippines
 - a. Certificate of Employment or DTI or SEC
9. Processing time: 3 working days (not including the day of filing)

FOR CHILDREN OF KOREAN MARRIED TO FILIPINOS (Tourist Visa)

1. Application Form; 1 piece of Passport size colored picture
2. Original passport (valid more than 6 months); Photocopy of Passport Bio-page (page 2)
3. Original and photocopy of valid visa/s and arrival stamps to OECD member countries for the past 5 years (if applicable, and Korean Visas will not be count)
4. NSO Birth Certificate
5. Certificate of KOREAN Family History (w/in 3 months)
6. Parent's KOREAN Marriage History (w/in 3 months)
7. Copy of Korean Father's Passport (first page)
8. Processing time: 3 working days (not including the day of filing)

FOR SEAMAN'S WIFE (Tourist Visa)

1. Application Form; 1 piece of Passport size colored picture
2. Original passport (valid more than 6 months); Photocopy of Passport Bio-page (page 2)
3. Original and photocopy of valid visa/s and arrival stamps to OECD member countries for the past 5 years (if applicable, and Korean Visas will not be counted)
4. NSO Marriage Certificate
5. Husband's passport copy
6. Guarantee Letter from Philippine Agent or Korean Agent
7. Copy of Husband's Contract
8. Personal Bank Certificate

FOR FILIPINO HOUSEWIFE

1. Application Form; 1 piece of Passport size colored picture
2. Original passport (valid more than 6 months); Photocopy of Passport Bio-page (page 2)
3. Original and photocopy of valid visa/s and arrival stamps to OECD member countries for the past 5 years (if applicable, and Korean Visas will not be counted)
4. Husband's Original Certificate of Employment (with contact number/s and address of company and date of issue)
5. Husband's Original Personal Bank Certificate (NOT Bank Certificate)
6. Husband's Photocopy of ITR (Income Tax Return) or Form 2316
7. Original and photocopy of NSO Marriage Certificate
8. Affidavit of Support Notarized from husband

FOR SENIOR CITIZENS AND/OR RETIRED OCCUPATION

1. Application form; 1 piece of Passport size colored picture
2. Passport original (6 months. valid); Copy of Passport Bio-page (page 2)
3. Original and photocopy of valid visa/s and arrival stamps to OECD member countries for the past 5 years (if applicable, and Korean Visas will not be counted)
4. Original Bank Certificate and Senior ID
5. ACR I-card for foreigners

NOTE:

- If personally invited by Korean: Invitation Letter & Copy of Inviter's Passport
- If invited by Company in Korea: Invitation Letter & Copy of Korean Company Business Permit
- Above Documents must be Original, and will return when the visa release.
